Introduction

- ❖ **The Olympic Games will be held from 8 August to 24 August 2008.**
- ❖ **The Paralympics will be held from 6 September to 17 September 2008.**
- ❖ **The main venue is in Beijing.**
- ❖ **Supporting venues are in Tianjin, Qingdao, Shanghai, Shenyang, Qinghuangdao and Hong Kong.**
- ❖ **Mainly to improve the air quality, the Government is considering a variety of measures -- some of which may impact the supply chain.**
- ❖ **Formal announcements are issued on local city or district level with relatively short notice.**
- ❖ **Shipping lines and airlines issue their own restrictions, which are subject to changes.**
- ❖ **BDP provides regular updates on the measures taken, the potential impact, and steps that can be taken to mitigate the impact.**
- ❖ **Supplementary information, for reference purposes, is provided in Appendix.**
- ❖ **Updated information on issues are marked in red.**

- ❖ **Part of the restrictions being considered have been formally confirmed:**
 - **Restrictions announced by Maritime Bureau apply at Shanghai Port**

Note: Shanghai Port/Dangerous Goods Terminal issued a list with UN numbers, see Appendix identifying products restricted between 18 July to 31 August 2008
 - **Restrictions announced by Maritime Bureau apply to Ningbo Port**
 - **Restrictions announced by Maritime Bureau apply to Qingdao Port**
 - **Traffic restrictions announced by Tianjin Municipal Government**
 - **Traffic restrictions announced by Beijing Municipal Government**
 - **Confirmation of controls on 257 products by Ministry of Public Security**
 - **Restrictions announced by CAAC on Air Cargo applies to Chinese airlines only**
 - **Update: CAAC required strict enforcement of air cargo inspection**
 - **Update: Shanghai airport announced restrictions applying to classified products**

- ❖ **Because of the limited amount of information, it is critical to realize the following:**
 - **Only the above restrictions are formally announced.**
 - **The formal announcements have lead to different interpretations.**
 - **There are many rumors circulating in the market leading to a high degree of uncertainty.**
 - **This BDP Advisory purpose is to provide as much information as possible, strictly for reference purposes only. Due to the limited, formally confirmed announcements, it is not possible to provide an accurate prediction on the impact.**
- ❖ **The recommendations to mitigate the potential impact have remained unchanged.**

- ❖ **Formal announcement from Shanghai Port Authority:**
 - **Shanghai Port Authority announced a list of products that will be restricted to load, unload or transit in Shanghai Port from 18 July to 31 August 2008.**
 - **The product list provides a Chinese description, which is interpreted differently by various shipping lines. This has resulted in announcements by shipping lines containing different English product names and DG Class and UN codes. The announcements by shipping lines are updated/changed frequently and may not be followed by overseas port of origin office.**
 - **The actual restriction on booking acceptance needs to be verified at the port of origin at the time of shipping and may differ from the announcements.**

- ❖ **Other ports:**
 - **Ningbo and Qingdao Port have meanwhile issued a formal announcement; information is included in this issue. It is expected that other China ports will follow the announcement in Shanghai.**
 - **Even when other ports do not formally make an announcement, it is expected shipping lines will follow the Shanghai announcement for all China ports (excluding Hong Kong).**

❖ **Formal announcement from Shanghai Port Authority, continued:**

- **From 20 July to 31 August 2008, Shanghai Port will cease handling loading and unloading of the below listed products.**
- **As of 18 July 2008, Shanghai Port no longer accepts applications for below products. From 25 August 2008 onwards, applications will be accepted (subject to the loading/unloading date being after 31 August)**
- **List of products subject to restrictions in Shanghai (informal translation from Chinese):**
 - Explosives***
 - Organic peroxides***
 - Hyper-toxic products***
 - Radioactive products***
 - Hydrogen peroxide***
 - Acetone***
 - Sulphuric acid***
 - Hydrochloric acid***
 - Nitric acid***
 - Ammonium nitrate (including ammonium nitrate fertilizer)***
- **Since there is no formal translation into English, there are many different interpretations.**

❖ **Formal announcement from Shanghai Port Authority, continued:**

▪ **Restrictions announced by shipping lines:**

- **Most shipping lines base the restrictions on the restrictions issued by the Shanghai Port based on their own interpretation.**
- **It should be noted that the Chinese version prevails, and this may cause large differences in interpretation. The most commonly used classification following IMDG code is as follows:**
 - 1, 5.2, 6.1, 7,**
 - 5.1 (UN 1511, 2014, 2015)**
 - 3 (UN 1090, 1091)**
 - 8 (1830, 1831, 1832, 2796, 2031, 2032, 1789)**
 - 9 (UN 2071, 2067, 3375, 2426)**
- **There are shipping lines that continue to accept bookings on a case by case basis.**
- **It is critical to continue checking with shipping lines on the actual status of restriction or booking acceptance, which may change from one sailing to another.**
- **Important!: Shipping lines' booking acceptance at origin does not warrant that the shipment can be released at China port at time of arrival. The port may detain the shipment after arrival with all cost to be born by shipper.**
- **Attached appendix includes tables with restrictions as announced by some of the shipping lines, this is strictly for reference only as it is changed regularly.**

- ❖ **Formal announcement from Shanghai Port Authority, continued:**
 - **Restrictions announced by Shanghai Port Dangerous Goods Terminal:**
 - **The Dangerous Goods Terminal has issued a detailed list, showing the DG class and the UN numbers of the products that will be restricted between 18 July to 31 August 2008.**
 - **If shipping lines align themselves with this list, from a practical point of view, it will result in increased possibilities to ship products in and out of China.**
 - **It may take some time before the shipping lines have distributed this information and issue a new guideline within their network.**

- ❖ **Formal announcement from Ningbo Port Authority, continued:**
 - **The Dangerous Goods Warehouses/Terminals need to register with Maritime Safety Bureau before 20 July 2008.**
 - **The BDP Warehouse was timely registered.**
 - **Shipping lines carrying chemical products need to register with Maritime Safety Bureau prior to entry into Ningbo port.**
 - **Chemical products which were not handled at Ningbo port in the past are considered a new product and will be prohibited from handling at Ningbo port.**

- ❖ **Formal announcement from Qingdao Port Authority:**
 - **From 25 July to 30 September, will stop handling explosive and virulent cargo. No further identification such as UN numbers is provided. The manner in which the prohibited goods is described is similar to the description provided by Shanghai port. State-owned and large-scale MNC enterprises may apply for exemption.**
 - **From 21 July, the port authority will increase the inspection ratio for all DG classified products. Delays can be expected to import or export such products.**
 - **From 17 July, the port authority strictly enforces the requirement for DG classified products to be delivered 48 hours prior to expected loading on vessel.**

- ❖ **Formal announcement from Tianjin Municipal Government:**
 - **From 25 July to 20 September, Tianjin applies off/even license plate restrictions from 07:00-22:00 within the outer ring road. Outer ring road itself is excluded. The restrictions include: Beiching, Wuqing, Baodi, and Jixian districts.**
 - **From 25 July to 20 September, transportation of DG classified products is prohibited. Exemption can be obtained only if the Police Bureau provides a permit.**
 - **Air pollution levels will be measured daily and applicable restrictions will be adjusted and become more severe if the pollution levels exceed their set limit.**
 - **Activities contributing to high levels of pollution will be suspended or restricted. This includes construction sites, heavy industries and gas stations in close vicinity to the Olympic venue.**

- ❖ **Formal announcement from Beijing Municipal Government:**
 - **From 1 July 00:00 to 20 September 24:00, Beijing applies traffic restrictions. The link to this announcement is located at: www.ebeijing.gov.cn/default.htm**
 - **These restrictions include off/even license plate system, controls subject to yellow/green permit and specific restrictions on cargo trucks. Full text with details on the restrictions are attached in the Appendix.**

- ❖ **Formal announcement from Ministry of Public Security:**
 - **The Ministry announced on 12 July that with immediate effect until 30 September, there will be more strict controls on 257 products in China (previously there were rumors circulating in the market on this subject).**
 - **These controls include real name registration, fixed point sales system, permit system for production, sales, purchase and transport.**
 - **The local work safety and security authorities at Beijing, Tianjin, Hebei, Liaoning, Shanghai, Shandong, Qinghuangdao, Shenyang and Qingdao may implement more strict controls and add more products.**
 - **The list of products which was attached with the formal notice is attached in the Appendix and replaces the information list that was previously included.**

❖ **Airlines:**

- **CAAC has made an announcement on 2 June, indicating the following:**
 - **Import and export of DG classified shipment will be suspended at the airports located at Olympic venue cities from 1 July to 30 September 2008.**

Note: This restriction applies to Chinese airlines only.
 - **Only specific products required for medical purposes may be excluded from these restrictions.**
 - **At airports located in cities that have no Olympic venue, the transport of DG classified shipments will be subject to strict controls. Delays in import and export processing are to be expected.**
 - **Classes 2.3 poisonous gases, 6.1 and 6.2 are considered high risk goods and transport of these goods will be subject CAAC approval.**

❖ **Airlines:**

- **Update: CAAC announced on 23 July that air cargo inspections at Beijing have to be strictly enforced:**
 - **Cargo will be 100% subject to physical inspection (opening and re-sealing) and scanning**
 - **Oversized cargo will be subject to 72 hour advance delivery requirement**
 - **From 25 July to 30 September, air cargo traffic with Pakistan, Kirgiz, Tagalog, Turkmenistan, Uzbekistan will be prohibited.**
- **Update: Shanghai airport on 5 August announced restrictions effective immediately:**
 - **Until 15 October, collection of imported flammable/explosive (CAT 2.1, 3, 4, and 5) is only permitted before 10:00 and after 16:00**
 - **Until 25 August, import of explosive (CAT 1), virulent (CAT 2.3 and 6), and radioactive (CAT 7) are prohibited**

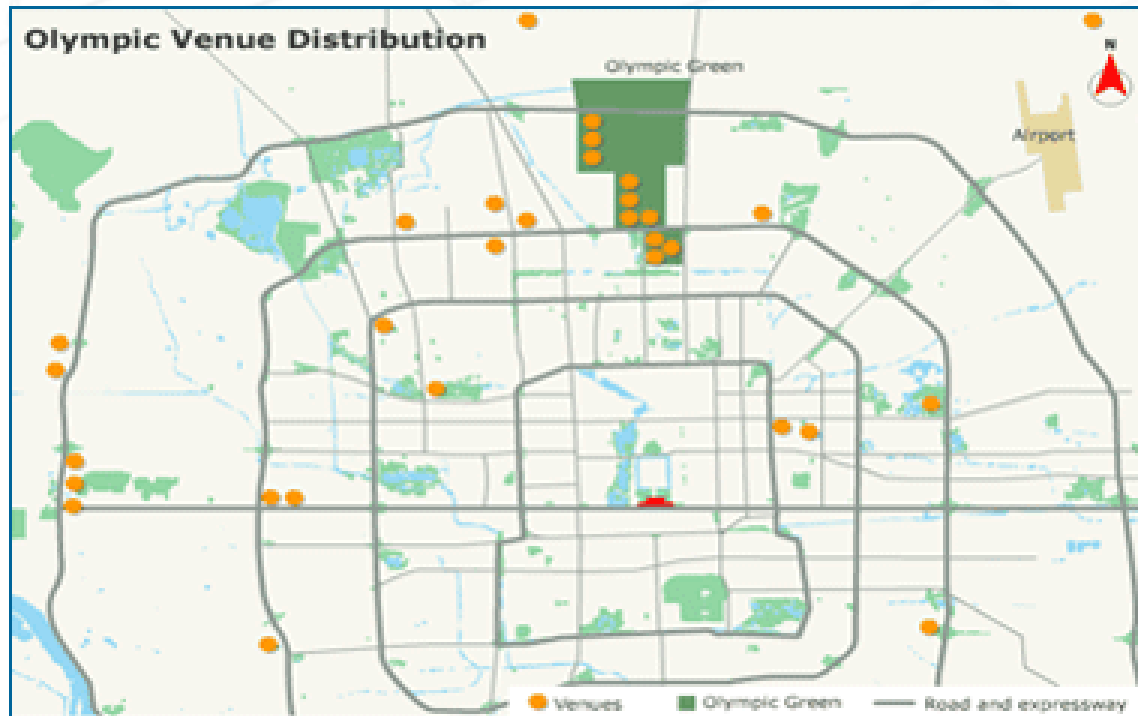

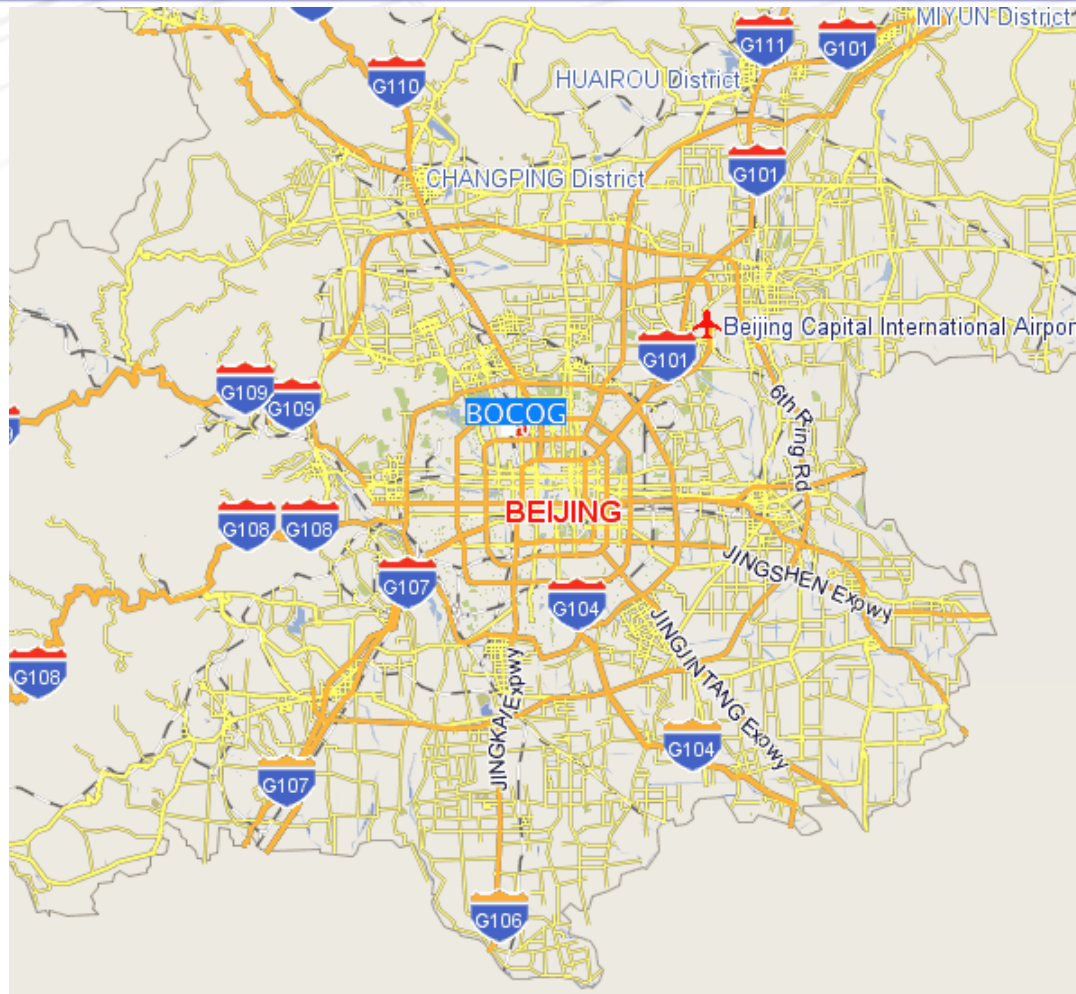

 - **The reporting requirement is effective as of 19 May until 20 October. Actual implementation is by local and district authorities**
 - **The term “hyper-toxic” is a local definition and not the same as the IMDG code class 6.1 toxic products classification.**

Public Notice of Beijing Municipal People's Government on Temporary Traffic Control Measures for Beijing-Registered Motor Vehicles During the 2008 Beijing Olympic and Paralympics Games

The Beijing Municipal Government hereby announces:

In order to ensure smooth traffic flow and good air quality during the 2008 Beijing Olympic and Paralympics Games, a commitment made by the Beijing Municipal Government during the bidding for the Olympic Games, and in pursuance of the Resolution of the Standing Committee of the Beijing People's Congress on Further Improvement of Law and Order for the Smooth Preparation for and Successful Running of the Olympic Games, the Municipal Government has decided to adopt the following temporary traffic control measures for the Beijing-registered motor vehicles (including vehicles with temporary license plates) from July 1 to September 20, 2008.

1. From the zero hour of July 1 to the 24th hour of September 20, vehicles with yellow environmental labels or test license plates shall be banned off the road within Beijing's administrative region.
2. From the zero hour of July 20 to the 24th hour of September 20, Beijing-registered vehicles with plates ending in odd numbers shall be allowed on the road on odd dates and those with plates ending in even numbers shall be allowed on even dates. Vehicles with 2002 edition license plates shall be treated as even numbers. The odd-even traffic restrictions apply to all the roads within Beijing's administrative region from the zero hour of July 20 to the 24th hour of August 27, and the roads within the 5th Ring Road (inclusive), the Airport Expressway, the Badaling Expressway (between Shangqing Bridge and Xiguan Roundabout), and the Jingcheng Expressway (between Laiguangying Bridge and Baima South Bridge) from the zero hour of August 28 to the 24th hour of September 20.

3. The following motor vehicles shall be exempt from the odd-even traffic restrictions:

- (1) Police vehicles, fire engines, ambulances, engineering rescue vehicles, and the on-duty vehicles of the PLA and the armed police;
- (2) Buses, trolley buses, inter-provincial long-distance passenger coaches and large buses, taxis (excluding leased vehicles), transit minibuses, and tour coaches with licenses issued by Beijing Municipal Administration of Transportation;
- (3) Vehicles with the Olympic passes (excluding those with the yellow-colored temporary passes for the venues and their soft domains) issued by the Beijing Organizing Committee for the Games of the XXIX Olympiad (BOCOG), or vehicles with the passes (subject to the requirements for the use of these passes) issued by Beijing Traffic Management Bureau ;
- (4) On-duty law-enforcement vehicles for municipal administration, industrial and commercial administration and traffic control identifiable by their marks, environment monitoring vehicles, rescue vehicles and wreckers;
- (5) Special vehicles for sanitation, landscaping and road maintenance (operating according to the approved time segments and routes);
- (6) Vehicles whose license plates carry the Chinese character "" (embassy) and those allowed to enter China temporarily;
- (7) Funeral vehicles of funeral parlors.

4. Postal trucks shall be exempt from the odd-even traffic restrictions. But postal parcel trucks shall be banned off the road within the 6th Ring Road (excluding the 6th Ring Road) from the 6th hour to the 24th hour (for unopened sections of the W. 6th Ring Road, they shall follow the traffic signs; the same below).




5. Rules for the following motor vehicles:

- (1) Cargo trucks shall be banned off the road within the 6th Ring Road (excluding the 6th Ring Road) from the 6th hour to the 24th hour.

- (2) Tractors, low-speed cargo vehicles and the tri-wheeled motor vehicles shall be banned off the road within the 6th Ring Road (inclusive) from the 6th hour to the 24th hour and within the 5th Ring Road (inclusive) from the zero hour to the 6th hour.
- (3) Motorcycles whose license plates carry "B" shall be banned off the road within the 4th Ring Road (excluding the side roads of the 4th Ring Road) twenty-four hours.
6. Vehicles carrying deadly poisonous chemicals shall be banned off the road within Beijing's administrative region from the zero hour of July 20 to the 24th hour of September 20. Vehicles carrying other dangerous chemicals shall be banned off the road within the 6th Ring Road (exclusive) from the 6th hour to the 24th hour, and shall observe the odd-even traffic restrictions for the rest of the day. All vehicles carrying dangerous chemicals (including the deadly poisonous chemicals) shall obtain prior permission from Beijing Municipal Administration of Work Safety and Beijing Municipal Administration of Transportation (vehicles carrying deadly poisonous chemicals shall also present the certificates issued by Beijing Municipal Bureau of Public Security). For those that need to enter into the restricted areas, they shall apply to Beijing Traffic Management Bureau for passes and comply with the requirements for time segments and routes.
7. Vehicles carrying earth or slag shall be banned off the road within Beijing's administrative region from the zero hour of July 20 to the 24th hour of September 20.
8. Vehicle and vessel taxes and the road maintenance fee shall be reduced for the suspended vehicles during the Beijing Olympic and Paralympics Games. Relevant rules shall be announced separately.
9. Those violating the rules specified in this public notice shall be penalized by Beijing municipal department of environmental protection and Beijing Traffic Management Bureau according to the relevant national and municipal regulations and shall no longer be entitled to the preferential policy that reduces the vehicle and vessel taxes and the road maintenance fee.
